- **13.** Set the desired range to CRP values higher than 1 mg/dL OR 10 mg/L.
- **14.** Click "Add" and select a criterion. Enter "procedures" in the search field (Filter Criteria). Click "Finish."
- **15.** Select "Procedures by Grouper" and enter the procedures grouper created in step 1.
- **16.** Click "Add" and select a criterion. Enter "medication by grouper" in the search field (Filter Criteria). Click "Finish" (Note: a look-back range of 24 months may be set to look at imaging studies in the last 2 years).
- **17.** Enter the NSAIDs medication grouper created in step 1 and set the include.
- **18.** Click "Add" and select a criterion. Enter "encounters" in the search field (Filter Criteria). Click "Finish."
- 19. Set the encounters to "Ophthalmologist, Gastroenterologist, Podiatrist, Dermatologist, Rheumatologist, Orthopedist, and/or Physical Medicine/ Rehabilitation." Depending on how the encounters file was set up, results may vary.
- **20.** In the General tab, enter the desired Report Name (for example, "axSpA") and a Description.
- **21.** Click "Save and Run" to create the patient list. The list will display all patients matching the criteria. For the Back Pain criteria, set a filter to find only patients with a diagnosis of back pain longer than 3 months.

Option 2 – SlicerDicer:

- 1. Access SlicerDicer (click the Epic logo > Reports > SlicerDicer).
- **2.** Click "New" to start a new query.
- **3.** Click the drop-down arrow next to All Patients and select "My Patients" from the list.
- 4. Click + Add Criteria. A new window will display.
- **5.** Click the Age folder (depending on the system, this may be a unique folder or stored in the Demographics folder).
- 6. Set the age range to less than or equal to 45 years old.
- 7. Click + Add Criteria. A new window will display.
- 8. Select the All tab on the bottom of the SlicerDicer window to display all filters.
- **9.** Click the Diagnosis folder.
- **10.** Select the Diagnosis by Grouper filter from the available options.
- **11.** Enter the Diagnosis Grouper created in Step 1 in the search field and select it as a filter.
- **12.** Click + Add Criteria. A new window will display.
- **13.** Select the All tab on the bottom of the SlicerDicer window to display all filters.
- **14.** Click the Lab Components folder.
- 15. Click in the Lab Component field and enter "CRP."
- **16.** Set the desired range to CRP values higher than 1 mg/dL OR 10 mg/L.
- **17.** Click + Add Criteria. A new window will display.
- **18.** Select the All tab on the bottom of the SlicerDicer window to display all filters.

- **19.** Click the Procedures folder.
- **20.** Select the Procedures by Grouper filter and enter the procedures grouper created in step 1 (Note: a look-back range of 24 months may be set to look at imaging studies in the last 2 years).
- **21.** Click + Add Criteria. A new window will display.
- **22.** Select the All tab on the bottom of the SlicerDicer window to display all filters.
- **23.** Click the Medications folder.
- **24.** Select the Medications by Grouper criteria and enter the NSAIDs medication groupers created in step 1, and set the include in the search field.
- **25.** Click + Add Criteria. A new window will display.
- **26.** Select the All tab on the bottom of the SlicerDicer window to display all filters.
- **27.** Click the Encounters folder.
- 28. Select the Encounters criteria and add Ophthalmologist, Gastroenterologist, Podiatrist, Dermatologist, Rheumatologist, Orthopedist, and/or Physical Medicine/Rehabilitation to include in the search field.
- **29.** Click "Save As" to save the query (for example, "axSpA") and refine the query results.
- **30.** Export the new report to Reporting Workbench.
- **31.** In the General tab, enter the desired Report Name and a Description.
- **32.** Click "Save and Run" to create the patient list. The list will display all patients matching the criteria. For the Back Pain criteria, set a filter to find only patients with a diagnosis of back pain longer than 3 months.

1. Background, Instructions, and Limitations*

These instructions are created specifically to create a Patient List in the NextGen EHR system and will not work for other conditions, treatments, therapeutic areas, or on other EHR systems.

The processes outlined in this piece are variable and not all steps will apply to every health system. Any steps or settings that are not part of a health system's standard process should be excluded or modified accordingly. Any questions should be directed to the appropriate service provider. The practice is solely responsible for implementing, testing, monitoring, and ongoing operation of any EHR tools.

The suggested criteria are listed below. Not all criteria may be routinely documented in the EHR and depending on the level of integration of the practice or health system, some criteria may be unavailable. 2. NextGen

NextGen offers different options to create the patient report. An executable file can be run in the customer's EHR to create the results (a Crystal Report) using the attached file or, alternatively, users can run the report using the Reporting tool. Please note that manually running a complicated patient list can be time-consuming and the configuration data may require advanced knowledge of the data element. Both options are listed below:

Option 1: Run the attached report file

- **1.** Move the Crystal Report file to the Custom Report folder.
 - **a.** The folder location can be found in NG System Admin under Universal Preferences > Reports > Custom Report Path.
 - **b.** The typical folder location is: \nextgenroot\Prod\EMR\Reports\Custom.
- 2. Configure the report for use in the EHR.
 - **a.** In the EHR, navigate to File > Reports > Crystal Reports.
 - **b.** On the Report Dialog window, click "Report Setup." Set the fields as follows:
 - i. Report file: Select the report file just added to the folder.
 - ii. Report Type: Select "All Encounters for All Patients."
 - iii. Location: Leave blank. Specifying a location may break the report.
 - iv. Printer: Any selection is fine.
 - v. Description: Add any descriptive name that you like.
 - vi. Filter: Leave blank. Specifying a filter may break the report.
 - vii.Click "Add," and then "Exit."

- **3.** To run the report, on the Report Dialog window:
 - **a.** Expand the All Encounters for All Patients group.
 - **b.** Select the report added in step 2 above.
 - c. Click "Preview."
 - **d.** The report will open:
 - i. The report will prompt for the practice ID. The practice ID for most single practice enterprises will be "0001." Enter all 4 characters.
 - ii. Click "OK" to run the report.

Option 2: Use the Reporting tool from NextGen

- 1. Click on the File menu and select "Reports".
- 2. Click on Generate Report and select the desired setting (Enterprise/Practice).
- **3.** The NextGen Report Filter window will open.
 - **a.** Start by saving the report by clicking the Save button.
 - **b.** Enter a unique report name, and specify the report type.
 - c. Select at least yourself to be able to Run, Modify, and Save the report.
 - **d.** Note that as you build the report using the steps below, do not click the OK button, as that will run the report in its current state, without saving the report settings.
 - e. As you are building the report, click the Save button frequently.
- **4.** On the NextGen Report Filter window, the Settings List displays all available filters.
- **5.** Select the Patient filter.
 - **a.** Set the age range to less than or equal to 45.

- **6.** Select the Diagnosis filter. There are two tabs in this filter. Start on the Diagnosis Search tab.
 - **a.** Click the ellipsis.
 - **b.** Select the radio button next to ICD Code and search for code M54.5 using the field to the right of the 2 radio buttons.
 - **c.** In the Provider Data pane, select "M54.5" and click the right arrow to move the DX to the Description pane. Click "OK."
 - **d.** Back in the Diagnosis Search window, select the Who Have Ever Had checkbox.
 - e. Select "After" in the field below the checkbox.
 - f. In the Year field, select 2 to search for DXs going back 2 years.
 - g. Click "Add."
 - Repeat steps 5a 5g for all other ICD-10 codes from the inclusion criteria list.
- 7. Select the Orders filter.
 - **a.** Select "Laboratory" in the Select "Order Type" field.
 - **b.** In the Select Test section, click the ellipsis to open the Test Search window.
 - i. If you order lab tests via the NextGen Compendium, select the NextGen Test Definition radio button. Alternatively, if you order tests from a lab company compendium, select the Test Definition radio button.
 - ii. In the Description field, enter at least the first part of the test name, such as "c-rea." Click "Search."
 - iii. Use the right arrow to move any tests identified from the left pane to the right pane. Click "OK" when complete.

- **c.** Back on the Orders Filter, in "Include Patients," select the Who Have Ever Had checkbox. Below that, select "After" and then specify 2 years.
- **d.** Check the Show Test Results checkbox.
- e. Check the Numeric Comparison checkbox.
- f. Check the Latest Value Only checkbox.
- **g.** In the Result Description field, select "C-Reactive Protein" or any other description that your CRP results display as in the Orders Module.
 - i. To the right of the Result Description field, select "Greater."
 - ii. In the Value field, enter "1.0." This assumes that your lab returns CRP results in mg/dL. If, instead, your lab returns values in the units of mg/L, enter "10.0" in the Value field.
- **8.** Select the Procedure filter. There are two tabs in this filter. Start on the Procedure Search tab.
 - **a.** Click the ellipsis to open the Procedure Search window.
 - **b.** Enter the CPT code for which to search and click "Search."
 - **c.** Move the found CPT to the Description pane by selecting the code in the Provider Data pane and clicking the right arrow.
 - d. Repeat steps 8b 8c for any other CPTs to include. Click "OK" when done.
 - e. Back in the Procedure Search window:
 - i. Select the Include radio button.
 - ii. Select the Who Have Ever Had checkbox.
 - iii. Select "After" in the field below the checkbox.
 - iv. Select 2 in the Year field.

- **9.** Select the Medication filter. There are two tabs in this filter. Start on the Medication Search tab.
 - a. Click the ellipsis to open the Medication Search window.
 - **b.** Select the Name radio button and enter the medication name and click "Search."
 - **c.** Use the right arrow button to move any desired medications to the Description pane.
 - d. Repeat this process for any additional meds. Click "OK" when done.
 - e. Back in the Medication Search window:
 - i. Select the Include radio button.
 - ii. Select the Who Have Ever Had checkbox.
 - iii. Select "After" in the field below the checkbox.
 - iv. Select 3 in the Month field.
- **10.** Select the Provider filter and click the ellipsis.
 - **a.** Click the ellipsis in the Rendering Provider field.
 - **b.** Select all Ophthalmologist, Gastroenterologist, Podiatrist, Dermatologist, Rheumatologist, Orthopedist, and/or Physical Medicine/Rehabilitation providers and add to the Include window (check the radio button next to Include).
 - **c.** Set the Encounter Date field as desired.
- **11.** Select "Logical Group" filter.
 - **a.** Select all search types and click the down arrow to move the items down to the Logical Group listing.
 - **b.** Specify OR for each logical group.

- **12.** Select the Column filter. Here you can specify the columns to display.
- **13.** Save the report (again).
- **14.** Click "OK" to run the report.
